The Colorado Housing and Finance Authority's contribution is restricted to supporting the general operations and programs of the organization and may not be used to support any activity proscribed by Section 1-45-117 of the Colorado Fair Campaign Practices Act or advocacy in support or opposition to any state, federal, or local legislation.

## use of entrants' and winner's entries and privacy consent and release
